उपर्युक्त विषयान्तर्गत सन्दर्भित पत्र के कम में वित्त विभाग की आईडी संख्या 102202586 दिनांक 19.05.2022 द्वारा प्राप्त राय के अनुक्रम में कृपया निम्नानुसार आवश्यक कार्यवाही कराने का श्रम करावें :-

In the Sanskrit Education the Teachers regularly appointed during the period from 01 January to 30 June of the year as per the provisions of Service Rules has not been allowed salary for the period of summer vacation, whereas these persons are entitled to salary for the period of summer vacation. The provision relating to non payment of salary of summer vacation to the teachers pertains to ad-hoc appointments and not for the teachers regularly appointed as per the provisions of Service Rules.

Accordingly, It is advised as under:-

- 1. The teachers regularly appointed during the period from 01 January to 30 June as per the provisions of Service Rules are entitled to salary of summer vacation and they may be paid salary and also pension as per rules admissible to them if salary of summer vacation has already been paid to them.
- 2. Those regularly appointment teachers who retired and their pension cases are pending because of non payment of salary for the summer vacation period the may be sanctioned provisional pension and provisional gratuity immediately on the basis of last pay drawn at the time of retirement.
- 3. On revision of pay due to payment of salary of summer vacation their final pension and final gratuity may be revised on the basis of revised pay.

- 4. Cases for payment of salary of summer vacation, if pending in the court in their cases also payment of summer vacation salary may be made immediately and modified facts may be reported to the court for dismissal of the cases.
- 5. The proposal of the Director, pension that these cases may be decided without payment of summer vacation salary is not covered under the rules and the proposal of the Director cannot be agreed. It is also pointed out the FD is not in favour to allow finalization of pension cases without payment of salary of summer vacation as per rules.
- 6. It is advised that the procedure followed by the Directorate of Elementary Education, Rajasthan Bikaner vide order dated 28-07-2003 may be also be followed by the Director, Sanskrit Education to rectify the error committed in all such cases to avoid any further litigation.
- 7. It is advised that in cases where payment of salary of summer vacation has been made to the teachers of Sanskrit Education, on their retirement pension cases may be decided finally.
